

Office Order

1. Sh. Paramjit Singh, Secretary, Grewal Sports Association Kila Raipur filed a Civil Writ Petition No 2540 of 2012 before Hon'ble Punjab and Haryana High Court, Chandigarh.


2. Hon'ble High Court disposed off the above said Writ Petition on 10/2/12 stating that

“After hearing learned counsel for the petitioner and perusing the petition, without expressing any opinion on the merits of the case, writ petition is disposed off with a direction that, in case, the petitioner approach respondent no.4 Deputy Commissioner, Ludhiana, by way of a representation, the Deputy Commissioner, Ludhiana, shall take a decision thereon today itself in accordance with law.”

3. Petitioner has presented his representation before the undersigned pleading that applicant association be permitted to conduct the Bullock Cart Race in the ongoing Kila Raipur Sports Festival.

4. The undersigned has perused the representation, order of Hon'ble High Court and letters of Animal Welfare Board and Director Animal Husbandry, Govt of Punjab. After perusal of aforesaid documents, it has come to notice that petitioner wants to conduct bullock cart race in the ongoing Kila Raipur Sports Festival. But the letters No 9/2/2011-12/PCA dated 8/02/2012 issued by Animal Welfare Board of India & 3567 dated 8/2/2012 issued by Director Animal Husbandry, Government of Punjab clearly state that bullock Cart Race scheduled to be held in rural Olympics of Kila Raipur is illegal and has to be stopped. They have further stated that this involves violation of Section 11 of the prevention of cruelty to Animal Act 1960 and constitutes a contravention of the Government of India notification of 11/07/2011 and they have also written that bullock cart race must not be allowed to take place.

5. Since Animal Welfare Board of India and Director Animal Husbandry, who deal with the subject & are expert agencies on the subject, have declared this race as illegal, hence the representation to allow bullock cart race cannot be accepted. Announced.
